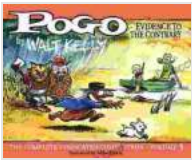

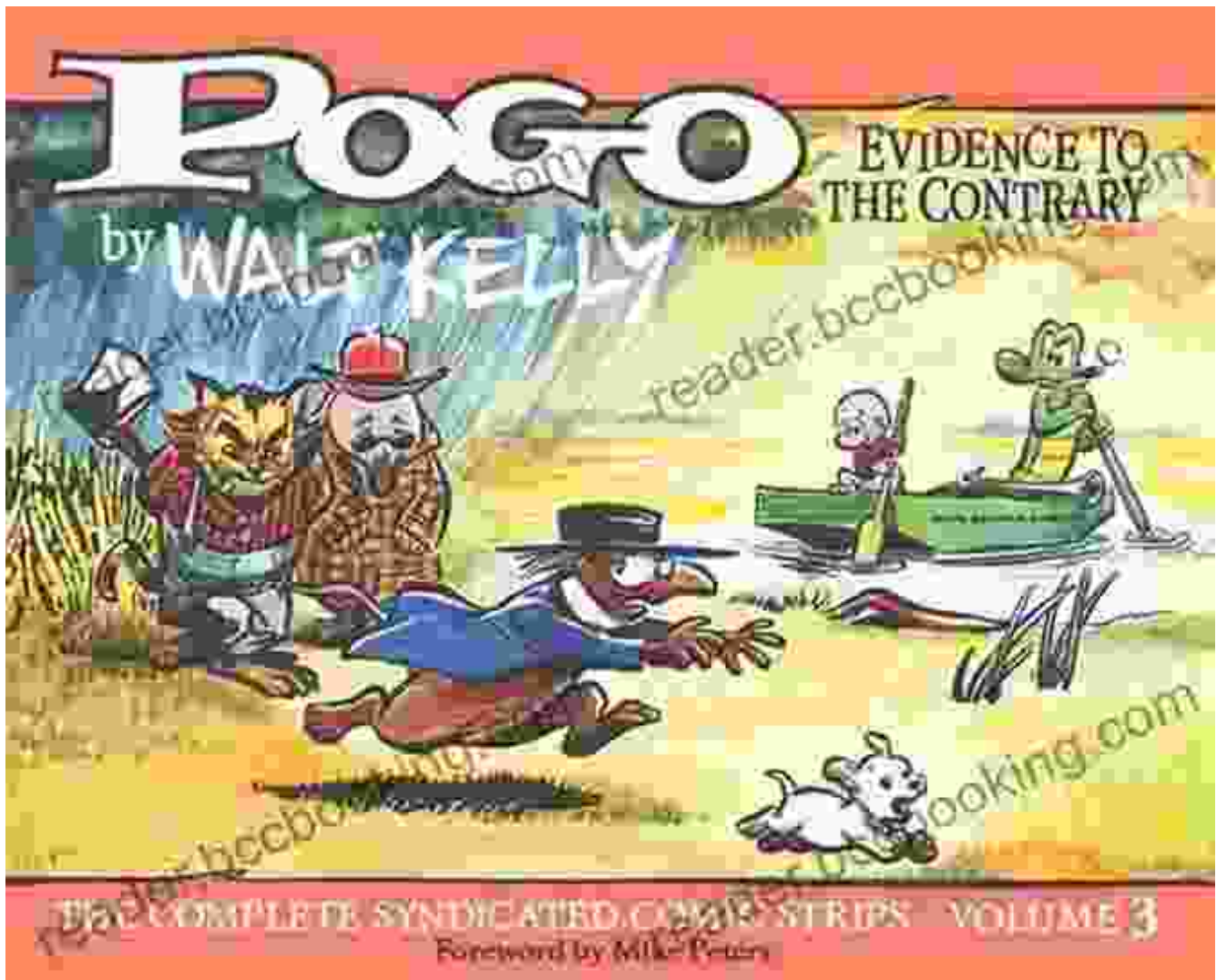

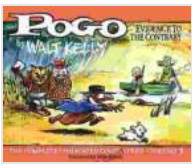
David Protest is a former prosecutor, legal scholar, and author. He is a professor of law at the University of Maryland, Baltimore County, and the
